REGISTRATION AND USE OF INFORMATION

No user is required to provide information in order to visit Shutter Guardian web site. A user must register, however, in order to receive email from us, to download data, to create a user account or to participate in some other Shutter Guardian services, a user may be asked to provide certain categories of information. Such as name, address, email address and date of birth. The information which you supply to Shutter Guardian enables us to customize our website to your interests and enhance your overall experience at our website. In addition, it helps us communicate with you about Shutter Guardian news, events, promotions and new products.

The Shutter Guardian website contains links to sites operated by third parties. These sites may collect personally identifiable information about you. This Privacy policy does not cover third-party data collection practices and Shutter Guardian does not assume any responsibility for third-parties. Please check the privacy policies at each site you visit.

PASSIVE COLLECTION OF INFORMATION

In addition to the information that you actively provide to Shutter Guardian, such as what you provide when you register for the Shutter Guardian services described above, Shutter Guardian collects information about how you interact with our website. Shutter Guardian collects passive information for purposes such as testing and improving a user's experience at the website and for compiling broad aggregate demographic data and related usage data for Shutter Guardian internal purposes. The types of passive information include, but not limited to, your IP address, which type of browser you are using, where you go on our website and how long you stay on any part of our website. We may also track how you interact with our website by assigning a random string of numbers and characters to your session. Passive information does not identify you to Shutter Guardian by name, and Shutter Guardian does not link your IP address to your personally identifiable information.

We use a cookie based data collection paradigm in certain areas of our website. Cookies are small files placed on your hard drive that assist us in providing customized services, for example, the use of cookies allows us to reduce the frequency with which you will need to enter your password on password-protection areas of our website. Additionally, in some cases, certain functionalities are only feasible through the use of cookies. You are always free to decline our cookies if your browser permits, although in that case you may not be able to use certain features on our website and/or you may be required to reenter your password more frequently during a session.

COLLECTION OF INFORMATION FROM CHILDREN

The Children's Online Privacy Protection Act and other laws have been established to protect the privacy of minors. Shutter Guardian abides by all federal and state laws and guidelines regarding youth privacy. As such, Shutter Guardian will not knowingly collect any personal information from young people under the age of 18, unless Shutter Guardian provides notice that such information is being collected and obtains verifiable parental consent.

SHARING OF INFORMATION

Shutter Guardian pledges that it will not sell or rent your information. Shutter Guardian may, share broad aggregate demographic data and related usage information with our business partners. This aggregate information does not contain any personal information which can identify any individual user.

While Shutter Guardian strives to protect the personal information of our users, Shutter Guardian will release personal information if required by law or in good faith belief that such action is necessary.

We may also use third parties that we refer to as internal service providers to facilitate or outsource one or more aspects of the business, product and service operations that we provide to you, and we may provide some of your personal information directly to these internal service providers. The internal service providers are subject to confidentiality agreements with us and other legal restrictions that prohibit their use of the information we provide them for any other purpose except to facilitate the specific outsource operation, unless you have explicitly agree or given your prior permission to them for additional uses. In some instances, the internal service provider may collect information directly from you. In these cases you will be notified of the improvement of the internal service provider, and all additional information you provide them and their additional uses will be strictly up to you. If you provide additional information to an internal service provider directly, then their use of your personal information is governed by their applicable privacy policy.

In the event that we, our parent company or certain of our assets or our parent's assets are acquired, user information may be included among the transferred assets.

Due to the existing regulatory environment, we cannot ensure that all of your private communications and other personal information will never be disclosed in ways not otherwise described in this Privacy Policy. By way of example (without limiting the foregoing), we may be forced to disclose personal information to the government or third parties under certain circumstances, third parties may unlawfully intercept or access transmissions or private communications, or users may abuse or misuse your personal information that they collect from the website. Therefore, although we use industry standard practices to protect you privacy, we do not promise, and you should not expect, that your personal information or private communications will always remain private.

SECURITY

Shutter Guardian has security measures in place to protect against the loss, misuse and/or unauthorized alteration of the information under our control. Shutter Guardian protects personally identifiable information by utilizing both online and offline security methods, including firewalls, passwords and restricted physical access of the places where your information is stored. Our staff is trained to comply with our security procedures, and our security procedures are regularly reviewed and revised, if necessary.
